 - Entries Close: The Monday before the show date or when 50 rides have been received, whichever comes first.

 - NO TELEPHONE ENTRIES WILL BE ACCEPTED.
 - Boots and Bandages are allowed
 - Horse Council Membership is mandatory. No exceptions.
 - All tests will be held in the 20 x 60 arena
