- Correct headgear required.
- Boots and Bandages are allowed
- Horse Council Membership is mandatory. No exceptions.
- Please enclose a photocopy of 2017 membership card for the rider and owner.
- Please return a signed Liability Release (attached) with entry: Juniors please have a parent or guardian sign. No signed Consent - No competition number.
- Entries Close: The Monday before the show date or when 50 rides have been received, whichever comes first.

- No refunds after the closing date.
- NO TELEPHONE ENTRIES WILL BE ACCEPTED.
- 50 rides is show limit. Less than 25 rides may cancel the show.
- Enter early because shows fill quickly
- You may only ride a maximum of three tests
- All tests will be held in the 20 x 60 arena
