- 50 rides is the show limit. Less than 25 rides may cancel the show.
- Boots and Bandages are allowed
- Horse Council Membership is mandatory. No exceptions.
- Enclose a photocopy of current HCBC membership card for both the rider and owner.
- You may only ride a maximum of four tests on the same horse
- All tests will be held in the 20 x 60 arena
- Please return a signed & witnessed Liability Release (attached) with entry: Juniors, please have a
 parent or guardian sign. No signed Consent No competition number.
- Entries Close: The Wednesday before the show date or when 50 rides have been received, whichever comes first.

Ride Times: Will be emailed the Friday before the show. Please ensure your email address is legible.

Tests:

- EC Tests will be used for English
- Horse Council tests will be used for Western
- Class 19 Test of Choice you are welcome to ride any test. Please provide a copy if it is not and EC or HCBC test.
- Class 20 10 minutes in show arena no judge
