### High-Point Awards in each Division

- attend 3 shows in series to be eligible
- follow the rules ie. "Correct Attire is Required"
- must show in classes/tests offered to be eligible
- prior winners (same horse & rider) are not eligible in same Division again must move up to win.

### Show Rules:

- **Please follow Government requirements for COVID-19**
- **PLEASE DO NOT PARK ON THE GRASS**
- **Absolutely NO dogs allowed on property**
- No refunds after the closing date.
- **BC Heritage and General Performance Rule Book - CORRECT ATTIRE IS REQUIRED**
- Telephone entries will NOT be accepted
- Emailed entries must include all required information and payment – [windsumenterprises@gmail.com](mailto:windsumenterprises@gmail.com)
- Correct headgear required.
- 50 rides is show limit. Less than 25 rides may cancel the show.
- Boots and Bandages are allowed
- Enter early because shows fill quickly
- **Horse Council Membership is mandatory. No exceptions.**
- You may only ride a maximum of three tests
- **Enclose a photocopy of 2020 membership card for both the rider and owner.**
- All tests will be held in the 20 x 60 arena
  
- **Please return a signed & witnessed Liability Release (attached) with entry:** Juniors please have a parent or guardian sign. **No signed Consent - No competition number.**
  
- **Entries Close:** The Monday before the show date or when 50 rides have been received, whichever comes first.

**Ride Times:** Will be emailed the Friday before the show. Please ensure your email address is legible.

### Tests:

- EC Tests will be used for English
- Horse Council tests will be used for Western
- Class 19 Test of Choice – you are welcome to ride any test. Please provide a copy if it is not and EC or HCBC test.
- Class 20 – 10 minutes in show arena no judge



## Show Information

Below is some additional information for the upcoming show. The information on this page is based on past show practices, and on current public health officer (PHO) recommendations during this COVID-19 outbreak.

Due to COVID-19 restrictions the following protocols are in effect:

- physical distancing, 6 feet or 2 meters is required
- hand sanitizer located at north and south entrances and encouraged
- there will be no concession
- this is not a HCBC sanctioned/approved show
- the boarder's alleys will be off limits as will the breezeway along the indoor arena
- entrance to washroom is at the south end of the facility

## Frequently Asked Questions (FAQ)

We are doing our best to provide a safe and healthy return to horse activities while making sure we respect our exhibitors and enjoy learning. Here are some answers you may have around the show.

### Where do I tack up my horse?

If you do not have a stall booked please tack up at your trailer. Those with stalls are welcome to tack up in their horse's stall. Please do not tack up in the alleys or the grooming areas used by the boarders

### Where do I warm up my horse?

The indoor arena will be open for warm up and cool.

## COVID-19 safety plans

Windsun Enterprises Ltd has developed and posted a COVID-19 Safety Plan as required by the PHO and WorkSafeBC that outlines the policies, guidelines, and procedures we have put in place to reduce the risk of COVID-19 transmission.

### Do I need to read the whole safety plan?

You do not need to read the plan unless you would like to, Windsun has worked hard to make sure that guidelines are being met while hosting this show.

### Where can I wash my hands?

The washroom will be open for handwashing, and there are two hand sanitizer stations located at the north and south ends of the building.

If your hands are physically dirty, handwashing (as recommended by the PHO) is the best method to reduce the spread of COVID-19. There will be plenty of soap and paper towels in the washroom.

### How do I need to conduct myself to ensure physical distancing?

Participants will need to keep 6ft (2m) away from each other and staff. We request that you do not touch any equipment that you have not brought yourself.

### Do I need to wear a mask at this event?

Masks are not required, however if you feel you are more comfortable or are unable to distance then we recommend you bring your own masks. We unfortunately only have enough masks for our staff.
